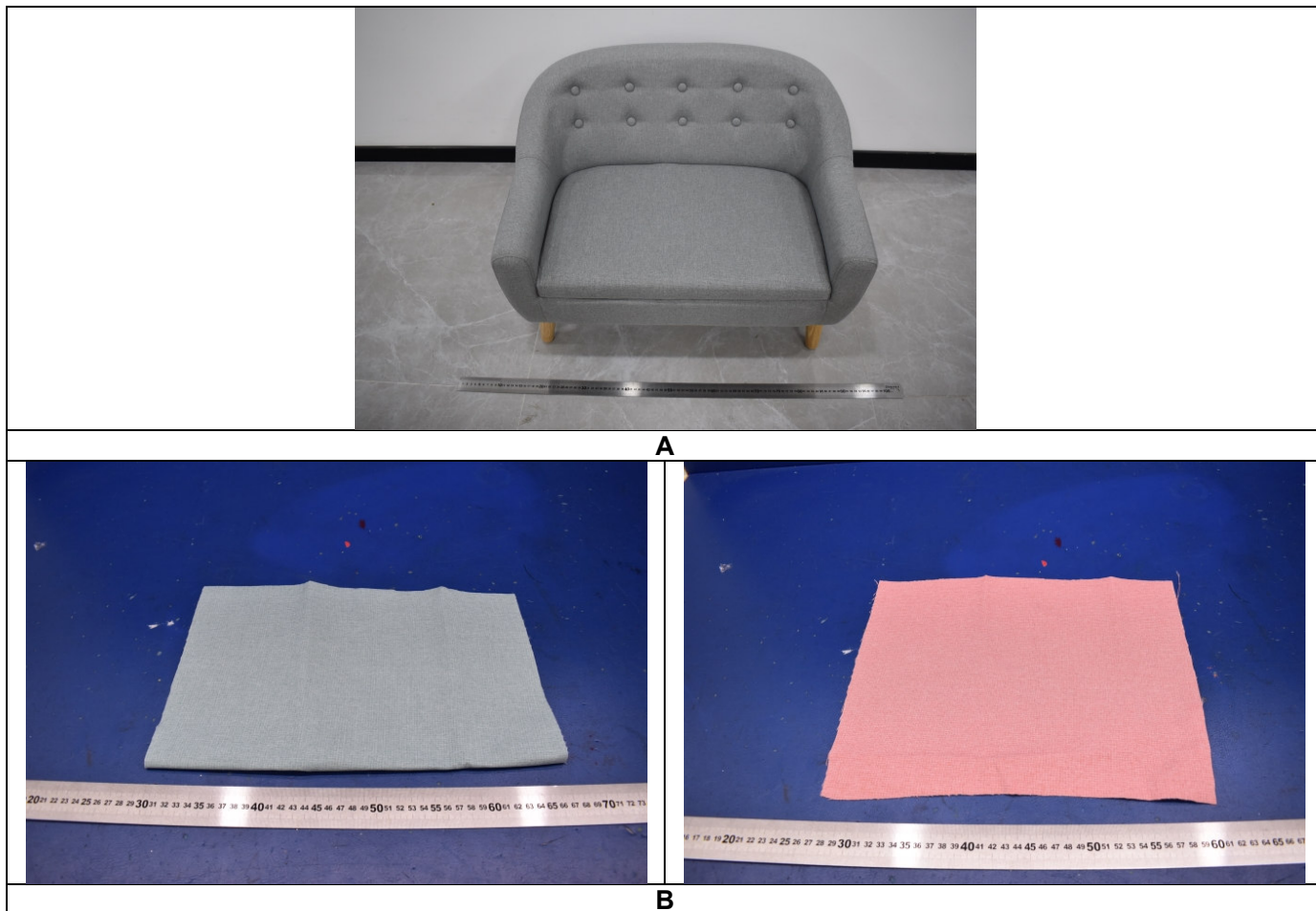

Test Request: Heavy Metals Content In Surface Coating as specified in Canada Consumer Product Safety Act - Toys Regulations, SOR/2011-17 amended by SOR/2018-138, Section 23

Test Method: Sample portion of surface coating was collected by mechanical method with surgical blade. Wet digestion with nitric acid for lead and mercury; migration of soluble elements of antimony, arsenic, barium, cadmium and selenium were performed in 5% hydrochloric acid after being stirred for 10 minutes at 20° C. All elements were analyzed by ICP-OES.
